International commercial Arbitration (ACICA).

The seat of arbitration shall be [Sydney/Melbourne/Perth/Brisbane/Adelaide], Australia. The language of the arbitration shall be English. The number of arbitrators shall be one or three.
- 16.3 If the amount in dispute is less than AUD \$100,000, the arbitration shall be conducted by a sole arbitrator appointed by mutual agreement. If the parties fail to agree within 14 days, the ACICA shall appoint the arbitrator.
- 16.4 If the amount in dispute equals or exceeds AUD \$100,000, each party shall appoint one arbitrator within 14 days of the notice of arbitration. The two appointed arbitrators shall select the presiding arbitrator within 21 days. If either party fails to appoint an arbitrator or if the two arbitrators cannot agree, the ACICA shall appoint the necessary arbitrators.

17 LIMITATION ON TIME TO FILE CLAIMS

Any cause of action or claim you may have arising out of or relating to these Terms of Use or the Website must be commenced within one (1) year after the cause of action accrues; otherwise, such cause of action or claim is permanently barred.

18 WAIVER AND SEVERABILITY
